It is applicable to the Tenderer carry out Development of Survey of onion varieties in onion production chain in the country

- The Tenderer shall either be a Government organization or Autonomous body or cooperative organization or a proprietorship firm or a partnership firm or a company registered under the relevant provisions of Companies Act of 1956 or 2013. In support of this tenderer shall produce a certificate in the Proforma prescribed at Annexure-A.
- 2. The Tenderer should have at least 5 years of experience in the field of survey of agricultural and horticultural commodities.
- 3. The tenderer should have prior experience and successfully completed assignments related to agriculture/horticulture in public sector, central or state government / autonomous bodies / statutory corporations.
- 4. The details of States to be covered under the onion production survey with number of districts are given at Annexure-B
- 5. The tenderer shall have to submit the audited balance sheet & P&L account for the preceding 3 FY i.e.; 2019-20, 2020- 21 and 2021-22.
- 6. The Tender shall be submitted in English language only. The tender notice and tender document shall form a part of the contract agreement.
- 7. NHRDF shall not pay any interest on the EMD and shall be returned to all unsuccessful bidders as early as possible within a period of 30 days from the date of issue of the contract award letter to the successful bidder.
- 8. The successful bidder within 7 working days from the date of acceptance of its offer shall furnish to NHRDF, security deposit of 5% of tender amount (after adjusting the EMD amount) through Demand Draft. EMD of successful bidder already paid shall be returned / adjusted after submission of aforesaid final bid amount by the bidder. EMD and security deposit of successful bidder will be clubbed together
- 9. If the successful bidder fails or neglects to observe or perform any of his obligations under the contract, it shall be lawful for NHRDF to forfeit either in whole or in part, in its absolute discretion the EMD furnished by the bidder.
- 10. Issue and/or submission of tender document do not mean that the Tenderer has qualified for award of work.
- 11. The original tender document shall be submitted with Annexures as per the procedure for submission of tender on or before due date and time. Financial bid is to be placed in separate sealed envelope mentioning on envelope FINANCIAL BID as per Annexure-C.
- 12. Tender will not be accepted If bidder is in the Banned list of Govt. Organization / PSU. Declaration for non-blacklisting shall be submitted as per Annexure-D.
- 13. Description of onion varieties utilization for onion production survey in India is given at Annexure-E.

- 15. The period of completion of survey and compilation of draft report will be 60 days from date of issue of work order
- 16. Payment will be made only after successfully completion of survey and submission of report as per actual work order
- 17. The comprehensive survey may be awarded to one firm or more than one firm as depends up-on competent authority of NHRDF for timelycompletion of above work
- 18. Very important instructions to be followed by the Tenderers.
 - i) The tender should be submitted in two bid system. Envelop-1 will contain technical bid and Envelop-2 will contain financial bid. Both envelops will be put in one envelope.
 - ii) Full address and name of the Tenderer should be indicated on the cover.
 - iii) The cover should also bear the tender no., the last date and time of submission of tender and the date time of opening of the tender.
 - iv) The Tender is likely to be rejected in case above details are not furnished on the sealed tenders.
 - v) Tenderers will have to go through the General Terms and Conditions applicable (as appended) and should note that these conditions are fully agreeable to him.
 - vi) Tenderers may further call for negotiation by the NHRDF committee formed by the Director, NHRDF.
 - vii) A two-stage procedure shall be adopted in evaluating the proposal. Technical evaluation shall be carried out first, followed by the Financial Bid evaluation. After the technical evaluation is completed opening of the financial bids will be done.
 - viii) Technical Bid evaluation Committee of NHRDF shall open all the tenders received in the presence of Bidders or their authorized representatives who wishto be present at the time of opening of Technical Bids.
