Doctoral degree in Agricultural Sciences including relevant basic sciences with minimum 8 years experience of high-quality postdoctoral research in an institution/organization as evidenced by at least 6 publication in journal with NASS rating of 7.5 or above.

Desirable: Experience in frontline extension/co-ordination and monitoring of extension programmes.
